Federal Trade Commission (FTC) Disclosure

Our charge for a direct cremation (without ceremony) includes: basic services of funeral director and staff; a proportionate share of overhead costs; removal of remains; transportation to crematory, necessary authorizations; and cremation if relevant.

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without and outside covering). The container we provide is a corrugated fiberboard container.

New York State Disclosure

If you want to arrange a direct cremation, you may use an unfinished wooden box or an alternative container. Alternative containers can be made of heavy cardboard, pressed wood or composition materials (with or without an outside covering), or may be pouches of canvas or other materials.

Direct Cremation includes the local transfer of remains to the funeral home, the services of the funeral director and staff, securing of necessary authorizations, local transportation by livery to the crematory, an alternative container for cremation and the return of the cremated remains to the funeral home.

In all, we offer 2 basic package services for direct cremations:

Direct Cremation with a cremation container supplied by the purchaser. (All such containers must meet any crematory requirements.) \$ 1495.00

The direct cremation prices do not include the crematory charge.

The direct burial prices do not include the cemetery charge.

Federal Trade Commission (FTC) Disclosure

Embalming is not required by law. Embalming may be necessary, however, if you select certain funeral arrangements such as a funeral with viewing. If you do not want embalming, you usually have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

New York State Disclosure

In New York State, embalming is not required by law. If you do not want embalming, you have the right to choose an arrangement, which does not require you to pay for embalming such as direct cremation or direct burial. If you select certain funeral arrangements such as viewing or an open casket funeral, the funeral firm may require embalming.

OTHER PREPARATION (Excluding Embalming)

Preparation of the remains, unless selected, is not required for direct cremation or for direct burial.
